

Transportation Plan Shamokin Area School District  
May 2022

In the event a student from Shamokin Area School District is placed into foster care at another LEA, the following procedures will take place.

1. Northumberland County C&Y will contact LEA and a Best Interest Determination meeting will be held. (Meghan Weaver)
2. If the student's Best Interest is to remain in the school district in which the foster care parent resides, foster care will enroll student in that district and records will be sent.
3. If the Best Interest is determined to remain in the home LEA (Shamokin), the following transportation procedures will be in place. (Best Interest is always the home school first unless otherwise noted)

Mount Carmel: MCA will transport the student Lourdes Regional School or Northumberland County Career and Technical Center. Shamokin will arrange transportation for the child from these schools to the attending school. (Contact: Tara Purcell or Carole Lubeskie)

Line Mountain: If within reasonable city limits, student will be transported by a Shamokin bus or the foster parent may need to transport the student to the district line / designated meeting place and meet with driver from Shamokin to attending school or Lourdes Regional School OR Northumberland County Career and Technical Center. Shamokin will arrange transportation from Lourdes Regional and NCCTC to attending school if needed. (Contact: Brad Shrum - 570-758-2640 ext. 6022)

Shikellamy: The student will be transported to Lourdes Regional School, and Shamokin will arrange transportation for the student to the attending school. Foster parent may need to transport the student to a bus stop or designated meeting place and meet with bus. (Contact: Brandi Weiser or Lewis Dellegrotti)

Southern Columbia: The student will be transported to Lourdes Regional School and Shamokin will arrange transportation for the student to the attending school. Foster parent may need to transport the student to a bus stop or designated meeting place and meet with bus. (Contact: Stephanie Zeigmont - (570) 356-3508)

Danville: The student will be transported to Lourdes Regional School or and Shamokin will arrange transportation for the student to the attending school.

Foster parent may need to transport the student to a bus stop or designated meeting place and meet with bus. (usually DTAC is the meeting point) These decisions will be made on a case-by-case basis. (Contact: Terri Faust & Laura Renno)

Warrior Run: These decisions will be made on a case-by-case basis. (Contact: Julie Petrin 570-649-5138 ext. 5011)
